Annual meeting recap: Co-op leaders recharge batteries

"The cooperative business model is the best business model on earth!" asserted Adam Schwartz, a consultant for cooperatives and an adjunct professor at the University of Mary Washington in Fredericksburg, Va. Speaking to more than 50 cooperative leaders at the Virginia Cooperative Council's annual meeting on March 6, he not only asked that they renew their commitment to the seven principles of cooperative living, but also charged them to recruit, train and mentor young people to share that passion.

"It's imperative that we teach the next generation about co-ops, and then make room in our organizations to give them positions of authority," Schwartz said. "What I have seen, especially among more mature cooperatives that have been around 75 to 80 years, is that the age of the board members and of senior management tends to be towards the higher end. If we really want our organizations to have a legacy and to go forward, we need to be working to bring young people into more positions."

Rural cooperatives have even more of an obligation to reach out to younger people, he added.

"If you're having problems with brain drain and young people leaving the community, one of the ways to get these people to stay in your area is to give them roots," Schwartz explained. "When they have positions of authority like being on the board or senior management, it makes them more likely to stay in their community."

Council & Foundation finance update

The Virginia Cooperative Council ended 2018 with total expenses of \$61,880.63 and \$5,190 in expense over revenue. This was primarily due to board-approved costs associated with developing the council's new website, www.virginia.coop, that uses a Wordpress platform.

The Virginia Foundation for Cooperation ended 2018 with \$23,951.40 in expenses and assets totaling \$581.574.79. Legal notice was published in the Feb. 24, 2019 edition of the *Richmond Times Dispatch*.

Adam Shiflett and state FFA officer Kendall Knicely gave an overview of last year's Virginia Institute on Cooperative Education and National Institute of Cooperative Education. VCC staff and members are actively working to recruit high school youth for the March 29-31, 2019 VICE, with registration forms posted online at www.virginia.coop

At the meeting VCC members bid a fond farewell to Allen Melton, the Council's retiring executive secretary, and welcomed Mary Howell, who started Jan. 2. With outgoing President J.T. Anderson and Eric Paulson stepping down at the end of three terms each, the board approved Richard Sladic of Culpeper Farmer's Cooperative to fill Jim Hunsberger's unexpired term, while VCC members elected Katie Frazier of Farm Credit of the Virginias to serve a three-year term as Director at Large. The board elected Richard Johnstone, CEO of the Virginia, Maryland & Delaware Association of Electric Cooperatives, as board president for 2019-2020 and Brad Brown of Augusta Cooperative as vice president. Jessica Harris was re-elected to serve as recording secretary and Tess Seibel succeeds Chandler Vaughan as FFA Advisor.

Before attendees enjoyed fellow ship over a buffet lunch catered by Mrs. Rowe's, Dr. Kim Morgan with the Virginia Tech Department of Agriculture and Applied Economics provided an update on the continued success of VCC scholarship recipients. On average, six students in the program receive \$2,000 scholarships from the Va. Foundation for Cooperation, and are heavily involved in hands-on research to aid cooperative members in the state, she said.
